ORDER:-

In the reference 1st read above, Government have issued orders relaxing ban on transfers from 25.04.2017 to 24.05.2017 and framed certain guidelines for effecting transfer of Government employees. In the reference 2nd read above, while communicating the G.O, certain instructions were issued to all the Government Degree Colleges in the State facilitating the employees to submit request transfer applications. In the reference 4th read above, Government have clarified that the employees who have completed 3 years of continuous service at a station but less than 5 years of service are eligible to apply for transfer only if they fulfill any of the five conditions laid down therein (such as medical and spousal grounds etc).

The video counselling was held on 22.05.2017 to consider and effect the transfers as per the options exercised by the employees. Accordingly, many of the employees are transferred to the places of their choice. However, some of the employees could not be accommodated at their place of choices as there are no vacancies and in such cases they are posted to the colleges where there are vacancies. Further, individuals who have completed more than 5 years of service at a station but have not exercised their option though online and are disturbed due to posting of another individual, are posted to needy Government Degree Colleges on administrative grounds.

In the light of the video counselling and on examination of all the cases with reference to G.O.1st and 4th read above, the transfers and postings are ordered in APCES as shown in the ANNEXURE - I with immediate effect.

The details of transfers considered at request or on spousal grounds or on administrative grounds are mentioned against their names respectively. The individuals who are transferred at request are not entitled for any T.T.A and joining time etc., as the postings are ordered at their request. The employees who are transferred on administrative grounds or posted to other than the place of their choices are eligible for TTA & joining time etc.

The Principals, Government Degree Colleges concerned are requested to relieve the individuals who are under orders of transfer at once without waiting for the substitute with instructions to report at his / her new station and report compliance.

In the reference 1st read above, Government have issued orders relaxing ban on transfers from 25.04.2017 to 24.05.2017 and framed certain guidelines for effecting transfer of Government employees. In the reference 4th read above, Government have clarified that the employees who have completed 3 years of continuous service at a station but less than 5 years of service are eligible to apply for transfer only if they fulfil the five conditions laid down therein (such as medical, spouse etc).

Instructions were also issued vide reference 5th read above to submit applications through online before the specified date and time i.e. 13.05.2017. But, the Principals / Lecturers mentioned in Annexure - II did not choose to submit application though they have completed 5 years of continuous service at their present station and fall under the provisions of para 3 (i) of G.O 1st read above. Therefore, on examination of all the cases with reference to G.O.1st and 4th read above, they are posted to needy Government Degree Colleges on administrative grounds with immediate effect.

The individuals who are under orders of transfer are entitled for T.T.A and joining time etc., as the postings are ordered on administrative grounds.





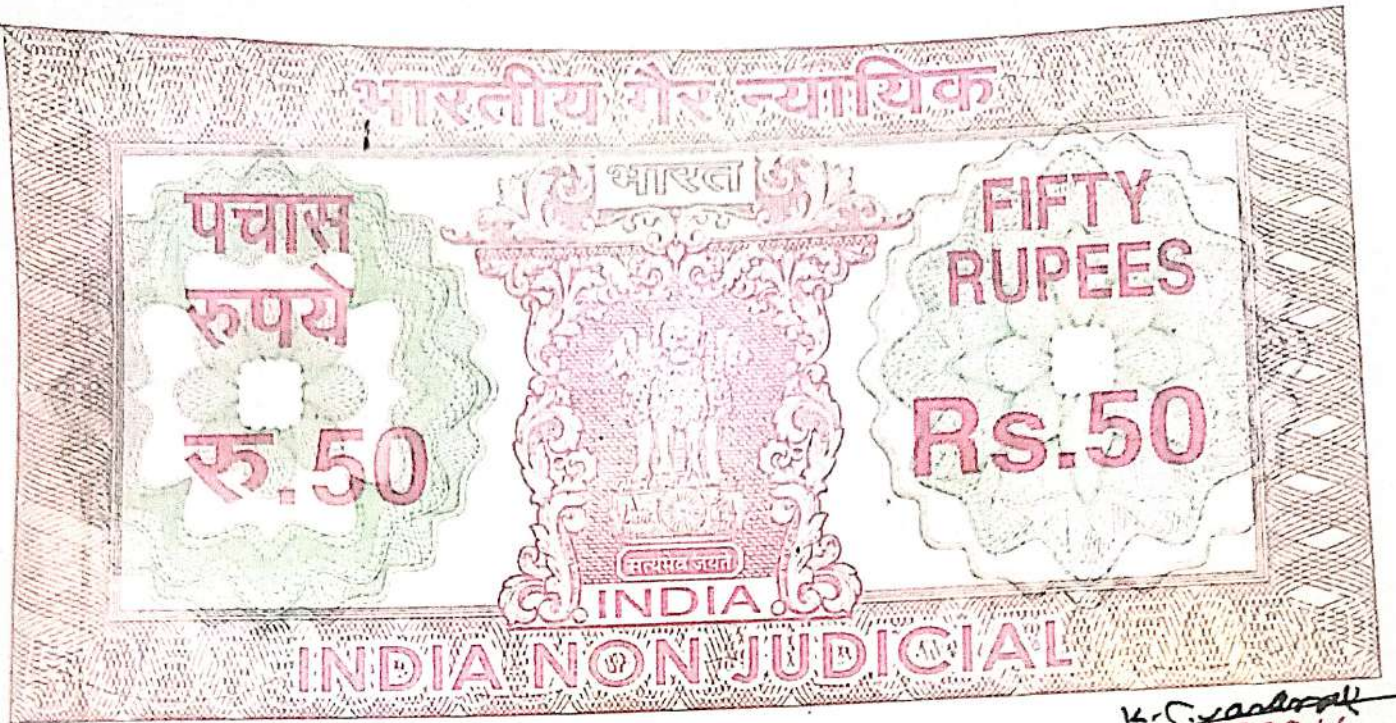
